COLLEGE FINANCIAL ASSISTANCE

Effective January 2017 the College Financial Assistance Program will be as follows:

- Required to carry at least 12 credit hours per semester and maintain a 2.5 GPA
- · Student is required to submit a College Financial Assistance application each semester.
- Max award per semester: \$500 per student. Check will be mailed to the student

We want to assist every student that is attending college and in order to assist eligible students the CFA Program had to adjust the amount of the award per semester. If you have questions or concerns please contact Heather Cozad.

The Secondary School Incentive program is available to enrolled Delaware children 5th12th grade. In September 2016 the program made some changes to the award amounts.
These changes were posted in the October/November and December/January
newspapers. Although the funding for the program is the same, the program made

excellence to reach their educational goals after high school. Since the program has a
lot more students entering, we want to be able to award each student that enters the

A copy of the student's report card with semester grades only. Please do not submit a report card with quarterly (9week) grades; the request will be mailed back.

- You may submit the request by (mail, fax or walk-in) to the Education office
- 5th-8th grade cannot have a grade lower than a "B" on any given subject
- A brief essay stating (page 3)
 - · The name and grade student
 - Age of student
 - What the money will be used for such as; clothing, games, class ring, class pictures etc.
 - · State that receipts will be submitted

APPLICATION SUBMISSIONS

FALL SEMESTER: Students can start submitting fall grades by January 1st SPRING SEMESTER: Students can start submitting spring grades by June 1st

ACADEMIC YEAR: August 31st is the deadline date for late fall and spring requests for

Qualifications and Requirements:

- Be at least 21 years of age;
- Have healthy relationships whether married, single separated or divorced;
- Have the ability to manage personal and household financial needs without relying on the foster care reimbursement:
- Fulfill the policy on background investigations for all household members 18 years and older by completion of criminal history background check; there must also be no history of alleged or confirmed child abuse, neglect or sexual abuse;
- Have a working vehicle. Vehicle must have insurance.
- Provide appropriate sleeping arrangements for each child placed:
- Be in good physical and mental health;
- Not to smoke in the home or automobile when the child is present:

DELAWARE NATION CHILD CARE INCOME ELIGIBILITY CO-PAYMENTS

The following scale (based on income and family size) is used in determining the family share co-payments to be paid by clients who are income eligible. All co-payments are to be paid directly to provider each month, not to exceed the amount charged. The Delaware Nation Child Care (CCDF) provider payments are made according to the balance of care cost after co-payments has been deducted.
